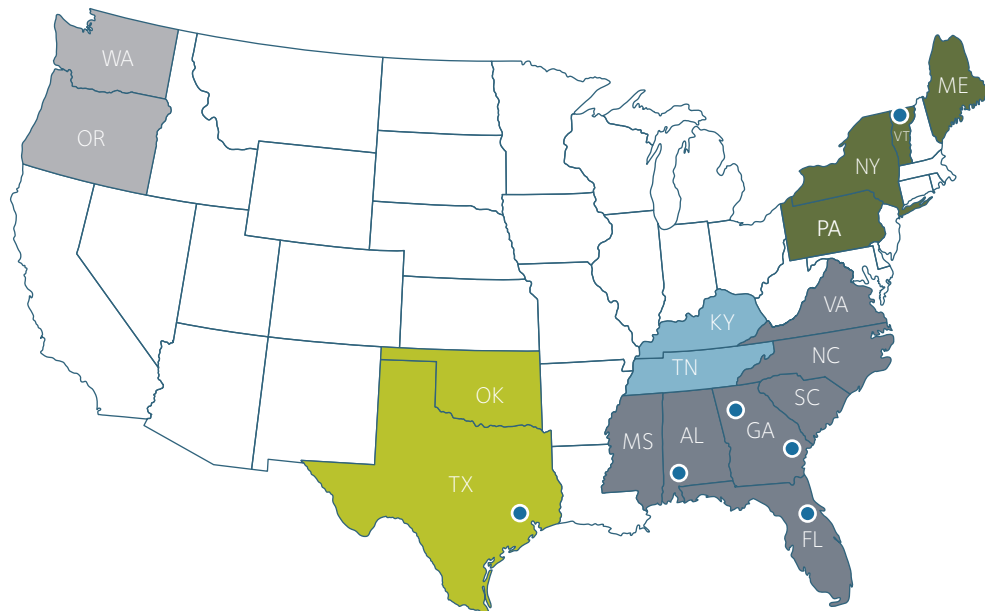


Timberland Footprint
